

Terms of Service Agreement

Welcome to revitalizAIR.com, operated by revitalizAIR LLC, located at 1150 NW 72nd Ave Tower I, Ste 455 #10443, Miami, Florida 33126. By using the website located at revitalizAIR.com, the related mobile website, and the mobile application (collectively, the "Websites"), you agree to be bound by these Terms of Service (this "Terms of Service" or "Agreement"), whether or not you register as a member of revitalizAIR.com ("Member"). If you wish to become a Member and/or make use of the service (the "Service"), please read this Agreement. If you object to anything in this Agreement or the revitalizAIR.com Privacy Policy, do not use the Service.

This Agreement is subject to change by revitalizAIR.com at any time, effective upon posting on the relevant website. Your continued use of the Websites and the Service following revitalizAIR.com posting of revised terms of any section of the Agreement will constitute your express and binding acceptance of and consent to the revised Agreement.
